


#### **Vale Alison Brown**

### **Seton Villa Families Stakeholder Satisfaction Survey**



A big THANK YOU to those families who participated in our recent anonymous stakeholder satisfaction survey to provide feedback on the quality of our services provided to residents and families. This survey contained the same set of questions provided by Xref (previously The Voice Project) two years ago, to enable the results to be benchmarked against a cohort of 60 disability service providers. In summary, our overall satisfaction level was 90%, slightly down from 93% in the previous survey. This 2024 survey also included our RASAID families for the first time.

The clear message from the survey is for us to improve our communication to families regarding the progress of their resident family member. I acknowledge this has been a challenge for us over recent months of inconsistent Accommodation Manager oversight. We are working hard towards greater stability and consistency across our Management Team that will certainly improve communication. I have attached the full survey results alongside this newsletter in my email to you all. ## Seton Villa Family Network WhatsApp Group



As introduced last month, the Seton Villa Family Network WhatsApp group is live, and I encourage more of you to sign up. It is a place where families can share their experience of the new 'myNDIS' PACE portal which is certainly presenting challenges as resident NDIS plans are reduced in value without any communication or consultation. Please remember that Persons Responsible are now required to proactively link Seton Villa to the new portal as Home & Living provider, SDA provider and (where appropriate) CP provider. It is **critical** that each component of the plan is separately linked, otherwise we will be unable to receive funding from the NDIA for services provided. Please email me directly with your request to 'opt in' to the WhatsApp group and I will link you. I will also provide you with a copy of our Privacy and Confidentiality policy for your reference.

# COVID-19 and Flu Update

The Department of Health currently advises that community transmission of COVID-19 and Influenza are at HIGH levels, and we will be maintaining the use of surgical face masks within the accommodation settings until further notice. Please wear a mask inside the home whilst visiting family members and remember to wash hands regularly and use the hand sanitiser provided at each location. We will continue to monitor this health advice.
